

**Statutory Fine and Fee Schedule - For Violations of:  
New York State Parks, Recreation and Historic Preservation Law  
and vehicle and Traffic Law**

All **Violation level offenses** other than traffic infractions as defined in section 155 of the New York State Vehicle and Traffic Law, are punishable under the Penal Law pursuant to §27.11(2). Penal Law §§70.15(4) (imprisonment) and 80.05(4) (fine):

- 1 Fine of \$0.00 - \$250.00 and/or up to 15 days confinement, **and** \$15.00 surcharge

All **Traffic Infractions** as defined in section 155 of the New York State Vehicle and Traffic Law: {Violations of sections 25.05-1, 25.05-8(a), 25.05-8(b), and 25.05-8(c)}

- 1 **First** conviction; Fine of \$0.00 - \$150.00 and/or up to 15 days confinement, **and** \$15.00 surcharge
- 2 **Second** conviction within 18 months; \$0.00 - \$300.00 and/or up to 45 days confinement, **and** \$15.00 surcharge
- 3 **Third** conviction within 18 months; \$0.00 - \$450.00 and/or up to 90 days confinement, **and** \$15.00 surcharge

All **violations of the Registration and Display requirements of Article 47** of the New York State Vehicle and Traffic Law:

- 1 **\$200.00 Mandatory fine** pursuant to VTL 2230-2, **and** \$85.00 surcharge Note: ½ of such fine shall be deposited in the snowmobile development and maintenance fund

Special Provisions **for PRL 25.24** – Operating a snowmobile on a street or highway or upon public trails or lands while under the influence of alcohol or drugs.

25.24-1(a) Operating while ability impaired by alcohol

- 1 **First Offense**;
  - o \$250.00 - \$350.00, **and/or** up to 15 days confinement, **and**;
  - o Suspension of that person's privilege to operate a snowmobile for a period of six months
- 2 **Subsequent offense** following conviction of any subdivision of 25.24 in the previous 5 years;
  - o \$500.00 - \$1500.00, **and/or** up to 30 days confinement, **and**;
  - o The court shall suspend a person's privilege to operate a snowmobile for a period of six months

25.24-1(b) Operating with a BAC of 0.08% or more, or

25.24-1(c) Operating while intoxicated, or

25.24-1(d) Operating while impaired by drugs

- 1 **First offense**; (Misdemeanor)
  - o \$350.00 - \$500.00, **and/or** up to 90 days confinement, **and**;
  - o The court shall suspend a person's privilege to operate a snowmobile for a period of twelve months
- 2 **Subsequent offense** following conviction of 25.24-1 (b), (c) or (d) within the preceding 10 years; (Misdemeanor)
  - o \$500.00 - \$1500.00, **and/or** up to 1 year confinement, **and**;
  - o The court shall suspend a person's privilege to operate a snowmobile for a period of twenty-four months
- 3 **Subsequent offense having twice been convicted** of 25.24-1(b), (c) or (d) within the preceding 10 years; (E Felony)
  - o \$500.00 - \$5000.00, and/or up to 4 years confinement, **and**;
  - o The court shall suspend a person's privilege to operate a snowmobile for a period

of twenty-four months

25.24-3 Operating while suspended. (Violation)

\$350.00 – \$750.00, **and/or** up to 90 days confinement.

If includes violation of any section of 25.24 (same incident), misdemeanor;

\$500.00 - \$5000.00, **and/or** up to one year confinement
